Attendee Terms and Conditions

These regulations constitute the general terms of agreement for Attendees of the LEGAL ® EVOLUTION Expo & Congress 2018 (the Event) organized by LEGAL ® EVOLUTION GmbH (the Organizer), which will be held between the 4th and 5th of December 2018 in Darmstadt.

1. Attendance of the Exposition and Congress

1.1. Rejection of Registrations

The Organizer may reject any registration for any reason within 9 days of an Attendee's registration for the Expo & Congress and/or the Networking Dinner. Should the Attendee have already paid the registration fee, the rejection becomes effective only upon repayment of the registration fee.

1.2. Entry to the Event

Should this occur, the Organizer will not refund any part of the registration fee and the Attendee will remain liable for the full amount.

2. Cancellation Policy and Transfer of Registration

2.1. The Attendee may transfer their event registration to a person of their choosing by informing the Organizer by email info@legal-revolution.com. The Organizer has

the right to reject the transfer only upon reasonable grounds. By accepting a transferred registration or by entering the Event, transferees, substitutes or proxies designated by the Attendee agree to be bound by these Terms and Conditions.

2.2. The Attendee may cancel their event registration by informing the Organizer by email at info@legal-revolution.com. The Attendee may choose between an equivalent ticket for the next event or a repayment of the registration fee, minus a 15% processing fee.

3. Force Majeure

- 3.1. The Event may be cancelled and not take place for any of the following causes including but not limited to: damage caused by fire, act of God, act of Terrorism, war, insurrections, strikes, the authority of the law, or for any cause beyond the Organizer's control.
- 3.2. The Organizer will, in the event the Conference does not take place for any of the above reasons, apply the registration fee for this Event to the registration fee of the next scheduled LEGAL ® EVOLUTION event. The Attendee has the right to demand the repayment of the registration fee.

4. Data Protection and Privacy Policy

4.1. Photography, Filming & Recording

Over the course of the Event, certain parts of the Event may be photographed, recorded, and/or videotaped. When registering for the Event you are also giving permission to be photographed, recorded and/or videotaped. These photographs, recordings and/or video tapes will be used for public display and/or sale after the Event.

- 6.2. Any disputes or claims arising out of or in connection with this Agreement (including its validity and non- contractual disputes or claims) shall be brought in and resolved by the courts of Frankfurt am Main to the extent permitted by law.
